Terms & Conditions for Cooperative Canteen Service

This is with reference to application received from the students and staff members on dated:-23/12/2021 the undersigned has constituted a committee on 28/12/2021 vide Dairy No.:-1892 to run a cooperative canteen service in the campus so that the staff and students will get the benefit of good quality eatable food in the canteen as well as keeping in mind the safety & security of the students due to close highway of this institution. The canteen will be managed by the students assigned by O/I canteen time to time & no interference of any staff member or outsider is allowed. The terms and conditions for the cooperative canteen service as per following details:-

- 1. The list of students is hereby attached who will take care/ manage everything for the cooperative canteen service under the supervision of Sh. Ranbir Singh, O/I Canteen. They are allowed to appoint workers who can prepare eatables & other items etc.
- Since the service of canteen is a cooperative hence it will run on "NO PROFIT NO LOSS" basis.
- 3. The institution shall provide free water for drinking and washing of the utensils and free Electricity for general illumination, refrigeration and aeration of the kitchen/ cooperative canteen service. The cost of shed will be borne by the members of cooperative canteen service with the help of charity.
- 4. The institution will provide suitable space for kitchen & sitting area for eating will be in the nearby parks within the institution. The kiosk and the good quality furniture for the cooperative canteen service in open area has to be provided by the institution.
- The eatable purchased by the committee of the students in the cooperative canteen service should be of good quality/standard & inspection should be done by the O/I Canteen time to time.
- 6. The rates of eatables should be displayed on the Notice Board in the cooperative canteen service.
- 7. The fuel to be used for cooking will only be LPG and shall be arranged by the committee of the students. No Kerosene Oil/ Coal to be used in the cooperative canteen service premises. The committee will use commercial LPG cylinder of ISI marked Petroleum Company for the safety & security of the cooperative canteen service. The committee also directed to report O/I Canteen if they found any difficulty for running of cooperative canteen service or any issue related to safety & security. Though the petroleum companies of LPG have govt. approved standards for safety, still one fire fighting extinguisher must be installed in the nearby areas of the cooperative canteen service.
- 8. O/I Canteen is also directed to ensure safety & security of the students ,staff & campus as per terms & conditions for canteen by the Technical Education Haryana time to time hosted on web portal www.techeduhry.gov.in

- Cooperative canteen services will be exclusively for the staff & bonafied students of this institution. No outsiders will be allowed to be entertained except with the prior approval of the competent authority.
- 10. The committee will be permitted to sell eatables, meals and aerated cold drinks tea and coffee only. The rates once fixed shall be applicable for one year.
- 11. The cooperative canteen service will not sell any item containing tobacco, alcohol or any other prohibited item in the cooperative canteen service.
- 12. The cooperative canteen service timing will be 09:00 A.M to 05:00 P.M on all working days of the institution and shall remain open during such days/hours as may be decided by the institution.
- 13. The committee will ensure high standard of hygiene and sanitation in and around the cooperative canteen service round the clock. Disposal of solid & liquid wastes will be responsibility of the committee with the help of O/I Sweeper of this institution. If, at any point the area of cooperative canteen service and its premises are found to be unclean the committee shall be held responsible. In this regard, inspection shall be carried out by a designated committee at any point of time by the undersigned.
- 14. The committee will furnish a list of workers employed for running and maintaining the cooperative canteen service. The workers to be employed in the cooperative canteen service must have attained the age of 18 years.
- 15. The institution campus is a no smoking zone, hence sale and use of tobacco is prohibited.

Inspection

Inspection of the material to be supplied in the cooperative canteen service to the staff & students will be carried out from time to time by a committee consisting who will have absolute right to reject such material, which is found to be sub standard.
